Some special educators in Kansas have dissatisfaction with the special education identification process and have an idea of how to better meet the needs of students that are struggling. Kansas State Department of Education Student Support Services Team awards IDEA Part VI-B Innovation Grants to local education agencies to address alternative assessment practices. Safe and Drug Free Schools begins statewide committee exploring how to better support students at-risk. KSDE begins piloting QPA process which focuses accreditation on student outcomes.
